



GS1 US is the US organization, which establishes identification standards for various industries (i.e. retail, healthcare) and licenses unique GS1 Company Prefixes, which are necessary to create UPCs.



Companies need to assign unique UPC barcodes for each product they sell, and this includes differences in sizes and colors. In order for companies to obtain UPC barcodes, they must join GS1 US, whose fee structure is based on the total number of UPC barcodes needed. By joining GS1, you will get your own licensed GS1 Company Prefix and a listing of assignable UPCs. In addition, you will have access to the GS1 US product data repository (Data Hub), so you can store and manage your UPC product information.

Our GS1 Barcode Services provide the necessary customer and technical support you need to properly identify and barcode your products. GS1 Barcode Service Agreement and Terms

The following agreement between, Bar Code Graphics, 'Service Provider' and 'Client' for services related to; Obtaining, Managing and Creation of UPC barcodes issued to 'Client' by the GS1 US.

Description of Services

Acting as an agent on behalf of Client, the Service Provider will complete and submit membership application to the GS1 US in Client's name as listed applicant. All payments for GS1 US membership, and renewals will be made by Client. Client agrees to review and accept terms specified by GS1 US.

Upon receipt of Company Prefix Certificate and Welcome email by GS1 US, Client will notify Service Provider of Company Prefix assignment. Service Provider will assist in managing UPC/GTIN data and facilitating barcode marking on products. Digital barcode files and/or printed labels will be furnished as indicated by product selection.

Terms and Fees

Service Provider will monitor Client's GS1 US Account and will assist with managing UPC's for a period of (1) year following the issuance of original UPC Assignments.

Service Provider will notify Client within (30) days of annual renewal fee being due.

Client can choose to have Service Provider process renewal, and continue to provide Professional Services related to this agreement, or Client can renew directly with GS1 US, and terminate this contract. All services provided under this agreement will be considered delivered by Service Provider and no further services will be provided in the event Client renews directly with GS1 US.

Client completion of placing an order executes this agreement confirms understanding of required total fees required; GS1 Membership fees, Bar Code Graphics GS1 Service Fee, as well as associated annual renewal fees. GS1 US does not endorse individual companies but provides a listing of certified Solution Partners.
